4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation. After skin contact: Repeated or prolonged excessive exposure may cause irritation.
